Please be advised that the Department of Design and Construction has the following project in preliminary design phases and it is included in our Fiscal Year 2009 Commitment Plan:

The scope of work for this project is the full street reconstruction of Herald and Greeley Squares, including reconstruction of the following streets:

Avenue of the Americas from West 32nd Street to West 35th Street.

Broadway from West 32^{nd} Street to west 35^{th} Street.

West 32^{nd} Street from Avenue of Americas to Broadway.

West 33^{rd} Street from Avenue of Americas to Broadway.

West 34th Street from Avenue of Americas to Broadway.

West 35th Street from Avenue of Americas to Broadway.

I have attached a sketch showing the limits of the project.

When DDC undertakes a sewer or water main project, it will be necessary to temporarily shut off water services in order to complete the work. If your community has occasions, observances, religious or other holidays when water shut offs would be particularly intrusive, or may require special planning, please include these in your correspondence. We will make every effort to include your concerns in the planning process.

Please share this information with your Board Members and the community residents and advise us within the next thirty (30) days of any concerns or issues that you believe we should consider during the design of the project. Please be advised that we may be unable to address any concerns you may raise after this time.


